As per the recently EC meeting approved about Elections, that the fellow membership requirement be relaxed for this time as the Bye-laws are still under approval by Registrar of Societies. However, only Life members will be eligible to apply as per the ByeLaws.

The SGBM has given different options for the online mode of conducting elections and TSI EC is in the process of finalising which should be decided within a week. Once decided, same will be notified again and probably nominations can also be submitted via online.

The nominated candidate, the proposer and the seconder should be life members of the Society. The nomination form must bear the signature of nominee indicating his/her approval along with signatures of proposer and seconder. Any nomination received after the fixed dead line will be invalid. As per the ByeLaws, the Vice President will be the President-Elect in the next year and similarly the President-Elect will be the President in the next year. Hence there will be no election to the posts of President and President- Elect.

### **Election Schedule:**

1. Nomination invitation from: 11- 09 – 2022.
2. Last date for receiving nomination: 11- 10 – 2022 till 5pm
3. Scrutiny and list of Nominations in order 13-10-2022, 5PM
3. Withdrawal, if any up to: 15- 10- 2022 till 5pm
4. Election, if necessary, 30.10.2022by secret ballot/voting online.
