The Guidelines of eligibility of candidates to contest for Executive Committee of TSI are based on TSI Bye-laws and Election Policy and Procedure approved on 21st Oct 2023, in the Special General Body Meeting.

Eligibility of Candidates to Contest for Executive Committee of TSI

Vice President

- The candidate should be life member of TSI (membership categories available in TSI Byelaw)
- The candidate should have been a member of TSI not less than 5 years.
- The candidate should have held any post in TSI Executive Committee previously (either as Executive committee member/Treasurer/ Joint Secretary / Honorary Secretary of the National TSI)
- Candidate cannot continue in the same post more than two terms consecutive or otherwise.

Honorary Secretary

- The candidate should be life member of TSI (membership categories available in TSI Byelaw)
- The candidate should have been a member of TSI not less than 5 years.
- The candidate should have held any post in TSI Executive Committee at the National or State chapter Executive committee previously (either as executive committee member /Treasurer / Joint Secretary of TSI / State chapter President, Vice President / Honorary Secretary/ Executive committee member)
- Candidate should have attended minimum of 3 Telemedicon in the previous 5 years.
- Candidate cannot continue in the same post more than two terms consecutive or otherwise.

Joint Secretary

- The candidate should be life member of TSI (membership categories available in TSI Byelaw)
- The candidate should have been a member of TSI not less than 5 years.
- The candidate should have held any post in TSI Executive Committee at the National or State chapter Executive committee previously (either as executive committee member /Treasurer / Joint Secretary of TSI / State chapter President, Vice President / Honorary Secretary/ Executive committee member)
- Candidate should have attended minimum of 3 Telemedicon in the previous 5 years.
- Candidate cannot continue in the same post more than two terms consecutive or otherwise.

Treasurer

- The candidate should be life member of TSI (membership categories available in TSI Byelaw)
- The candidate should have been a member of TSI not less than 5 years
- The candidate should have held any post in TSI Executive Committee at the National or State chapter Executive committee previously (either as executive committee member /Treasurer / Joint Secretary of TSI / State chapter President, Vice President / Honorary Secretary/ Executive committee member)
- Candidate should have attended minimum of 3 Telemedicon in the previous 5 years.
- Candidate cannot continue in the same post more than two terms consecutive or otherwise.

Executive Committee Member

- The candidate should be life member of TSI (membership categories available in TSI Byelaw)
- The candidate should have been a member of TSI not less than 5 years.
- The candidate should have held any post in TSI Executive Committee at the National or the State chapter previously (either as executive committee member /Treasurer / Joint Secretary of TSI / State chapter President, Vice President / Honorary Secretary/ Executive committee member)
- Candidate should have attended minimum of 3 Telemedicon in the previous 5 years.
- Candidate cannot continue in the same post more than two terms consecutive or otherwise.
